- 2. The Volunteer agrees to participate in and satisfactorily complete a B&B training program if requested by the executive director of Bark and Bray Farm and Animal Sanctuary
- 3. The volunteer agrees to be supervised by the Executive Director or their designee.
- 4. If an accident or injury occurs while the Volunteer is fulfilling their responsibilities, Bark and Bray Farm and Animal Sanctuary is authorized to seek emergency medical treatment on the Volunteer's behalf.
- 5. The Volunteer does not have, nor shall they hold themselves out as having any right, power, or authority to create any contract or obligation, either express or implied, on behalf of, in the name of, or binding upon Bark and Bray Farm and Animal Sanctuary.
- 6. The Volunteer agrees to hold B&B harmless from any and all claims, damages, and causes of action, including attorney's fees arising from services rendered by the Volunteer.
- 7. I expressly and knowingly acknowledge the potential dangers and assume the risk that may exist in volunteering around and caring for animals of all types including the potential for property damage, being bitten or injured, and/or death.
- 8. The Volunteer agrees to keep confidential all information acquired in the course of the voluntary services rendered both during the time the Volunteer is a Volunteer at Bark and Bray Farm and Animal Sanctuary and thereafter.
